General Business-

Tomahawk in Under 11

- Sunshine Coast raised the issue of the use of tomahawks being too dangerous in the Coulter Shield for Under 11 Boys.
- It was discussed that there are safety issues with a Tomahawk.
- As many Associations don't allow it in Under 11, Umpires coming to umpire at the Coulter Shield are not familiar with how to call the danger.
- It would be asked that each Association give their Umpires appropriate training in the use of the Tomahawk and what does make it dangerous, before attending the Coulter Shield.
- It would also be asked if each Association could teach their players the appropriate way to defend a Tomahawk, therefore eliminating some of the danger.
- It was agreed to leave the use of the Tomahawk as part of the game in Under 11's.
