General Business

Shirley Fullelove would like to have it minuted of the passing of Joyce Proctor (Brisbane) in 2016. Joyce is to be remembered on how good she was in the development of the Southern Cross League in its early years and all the work behind the scenes she did.

- Ipswich re responsibility of completing the Southern Cross completion draws. It was discussed that it was best to leave it to the Host Centre, as they have local knowledge of the fields, are able to sort of times etc depending of teams. All centres agreed to keep it to Host Centre.
- Pam Low Individual medallions to winning teams in U11s only. 16-17 players/team with approximate cost of \$260 divided between centres. Discussed if BWHA could use some of the Revenue associated with day be used to fund this cost.

It was moved by Pam Low and Seconded by Emma Zivani (Twmba) that a letter be written to BWHA asking if they could cover the cost of the medallions. Carried.

It was noted that at the 2016 U11 Boys Coulter Shield that the Brisbane teams were presented with medals, but not any other team. After further discussion it was advised that BHA donate these medallions to their boys' teams only and cover the costs themselves.

It was further discussed that at the Coulter Shield meeting it be mentioned that if Brisbane wants to give their teams medallions to do it in another location not at the main presentation as other teams are questioning why there is none for their teams.

It was also noted then to rescind the motion to send the letter to BWHA in regards to the cost of the medallions. Moved Pam Low Seconded: Emma Zivani.
